## **2019 Instant Win Digital Scratch Card Promotion**

## **Terms and Conditions of Entry**

- Information on how to enter and prizes form part of these Terms and Conditions of Entry.
  Participation in this promotion is deemed acceptance of these Terms and Conditions of Entry.
- 2. Entry is only open to residents of Australia aged 18 years or older. Employees of the Promoter and its agencies associated with this promotion and the immediate families of these people are ineligible. Once the details have been successfully submitted, an on-screen area will appear that the entrant can scratch, using either their fingers or a mouse, to reveal any instant win prizes.
  - 4.2 Entrant must scratch all nine (9) silver panels on the on-screen area. If three (3) identical Unique Prize Icons are not revealed, the digital scratch card is not a winner. If three (3) identical Unique Prize Icons are scratched, the digital scratch card is a winner.
