## "TRIVETT SUBARU SYDNEY WIN A HOLIDAY PROMO" PROMOTION

## TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to NSW residents aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoter, participating dealerships and agencies associated with this promotion are ineligible to enter. Draw method: An electronic draw will be conducted.
- 13. The Promoter's decision is final and no correspondence will be entered into.
